#### **TOWNSHIP COUNCIL MEETING**

# MAY 11, 2016

The meeting of the Springfield Township Council was called to order by Mayor McDaniel with Council Members John Hlubik, Anthony Marinello and Peter Sobotka present. David Frank was absent. Also present were Manager Paul Keller, Engineer Dan Guzzi and Solicitor George Morris.

The Sunshine Notice was read:

"Public notice of this meeting pursuant to the Open Public Meetings Act has been given by the Springfield Township Council in the following manner on January 10, 2016:

- b. Transmitting written notice to the Register News and the Burlington County Times
- c. Filing written notice with the Clerk of Springfield Township
- d. Mailing written notice to each person who has requested copies of the regular meeting schedule and who has prepaid any charges fixed for such services."

Mayor McDaniel led the salute to the Flag.

Mr. Sobotka made a motion seconded by Mr. Hlubik to approve the minutes of the April 7, 2016 work session. All were in favor. Motion carried.

Mr. Sobotka made a motion seconded by Mr. Hlubik to approve the minutes of the April 13, 2016 regular session. All were in favor. Motion carried.

# PUBLIC COMMENT ON AGENDA ITEMS

John Burton asked if the bidders present for the Hunting Lease Auction were pre-qualified and Ms. Clayton responded that they were not.

Hearing no further comments, Mr. Marinello made a motion seconded by Mr. Sobotka to close public comment on agenda items. All were in favor. Motion carried.

Mr. McDaniel presented a plaque to Mr. Jones for his 20 years of service for the Zoning Board. Mr. Jones stated that he replaced Mr. Pettit who served 30 years and he was sorry he could not make that long.

# **AUCTION – HUNTING LEASE**

Mr. Morris opened the auction on Bl. 403, Lot 3.01 approximately 109 acres with a minimum bid of \$4,500 with increase in increments of \$100 and the lease will be awarded to the highest qualified bidder and the Township has right to reject all bids. Mr. Morris opened the auction.

Mr. McDaniel asked if we have a problem if the bidders not being qualified. Mr. Marinello clarified that if the highest bidder can't provide the appropriate certificate of insurance that it would go to the next bidder. The auction closed at \$6200 with the highest bidder being Capital Rod and Gun.

# **REPORT FROM CHIEF ROBERT BERCY JACKSONVILLE FIRE CO.**

Mr. Bercy advised Council that the fire truck was now in service since February 2016 and the delay was because they did not want to do the training in the middle of winter. He added that they just had the truck to a drill and he presented pictures to Council. Mr. Bercy expressed

displeasure that he was summoned to a Council meeting instead of someone just picking up the phone and calling him to ask what was going on. Chief Bercy apologized for not notifying the Council that the truck was in service. He added that the truck has been at events it just has not been to any fires yet. Mr. Marinello asked if they are getting rid of the older truck and Chief Bercy responded that this one of the reason they participated in the drill to make sure they are capable of doing everything they can with the new truck before they got rid of the old one. Chief Bercy added that it is listed in some trade magazines. Mr. Marinello asked if there is a fire the new truck will be at the scene and Chief Bercy responded that it would be. Chief Bercy stated that he will have a dedication at the annual Fire Prevention event. Mr. Marinello asked about cross training and Chief Bercy responded that they do. Mr. Marinello asked if no one in Jacksonville was able to respond would another department be able to use that truck and Chief Bercy gave an explanation of how calls are responded to and how the grid works. Chief Bercy asked for a liaison between the Council and the emergency services and Mr. Marinello offered to be that liaison. Chief Bercy offered for Mr. Marinello to come to the line officer's meeting on the second Thursday of each month.

Mr. McDaniel stated that Council worked to reduce the tax increase by half of what was originally proposed. Mr. McDaniel stated that the snow storm added almost a penny to the increase and the debt service is up which added more than a penny. Mr. Sobotka stated that the Northern School Board adopted their budget and will raise taxes for the average homeowner about \$115 a year so he wants on the record that Council is aware of that impact on people.

Mr. Sobotka made a motion seconded by Mr. Hlubik to pay the bills. Mr. Keller stated we do have an additional bill of \$630.95 to settle the matter with Officer Cowperthwait. Mr. Sobotka amended his motion and Mr. Hlubik seconded it to include this bill. All were in favor. Motion carried.

#### CORRESPONDENCE

- 1. NJDEP BC Solid Waste Facility Permit Minor Modification.
- 2. NJ DOT 2016 Municipal Aid Program (Folwell Station Rd.)
- 3. NJ DOT 2016 Municipal Aid Program (Neck Road). Mr. McDaniel stated that we got a grant last year so we expected not getting another one this year for these two projects.
- 4. BC Right to Farm Recklesstown Spirits LLC Distillery B. 1001, Lot 1. Mr. Morris stated that this is just informational and it is still at CADB. Mr. Sobotka asked when these types of places open is there any training offered by the police to instruct them on drinking and driving. Chief Trout stated that they do not and Mr. Morris responded that it is the person running the facility's responsibility to get that training. Mr. Sobotka expressed concern about the drinking and driving since there are more of these types of places opening and Chief Trout responded the only thing the police could do is station an officer at the driveway and Mr. Keller added that we don't have the staff for that. Mr. Marinello stated that we would have to look at this

issue if it becomes a problem. The question was asked about taxes and it was discussed that it falls under Right to Farm and it would be taxed as a farm.

- 5. Nancy Bonsall (NJ Residents Against Puppy Mills) providing a Sample Ordinance. Mr. Marinello stated that this would limit the sale of animals other than by the shelter. Council felt that at this time they do not wish to move forward with an Ordinance.
- 6. Notice of Appeal RE: Haviland Zoning Board Approval. Mr. Morris explained that Council now has to review the application. Mr. Morris stated that Council will review the transcript and the applicant will be provided an opportunity to be present. Mr. Marinello asked if Denis Germano would appear and Mr. Morris stated that you could require him to attend. Mr. Sobotka asked if this was going to cost the Township anything since the appeal was filed by Mr. Akins who is the Chair and he was advised that Mr. Akins filed as an individual and the cost to the Township will be noticing. Council decided to have the hearing on June 8<sup>th</sup> meeting.
- 7. BC-Park Grant. Mr. Sobotka asked if we are applying the \$75,000 to the Juliustown Park and Mr. Guzzi stated that it would be for the path at Juliustown. Mr. Sobotka asked if that was for the basketball court as well and Mr. Guzzi responded that he will have to look at the estimate again to see if there would be enough money for both.

Mr. Sobotka made a motion seconded by Mr. Marinello to file the correspondence. All were in favor. Motion carried.

# ENGINEER REPORT

Mr. Guzzi stated that Arawak was back out working on the punch list from last year but he is not happy with some of the work they did on Jobstown-Juliustown Rd.

Mr. Guzzi stated the DOT gave verbal approval and are waiting on County approval for this year's road project and the road configuration. He added the County just requested a certificate of insurance and Mr. Keller stated that he is in the process of getting the certificate of insurance so it should be ready to go out to bid sometime next week. Mr. Guzzi stated that they will set up for the bike path with this project but not actual do the construction for the bike path. He added that the project includes demolition of buildings on the two properties and reconfiguring of road and Arneys Mt. Birmingham with the added inlets discussed last month. Mr. Guzzi suggested holding off on the bike path and Council felt that it should be included in this bid since we still have last year's grant money of \$75,000. Mr. Guzzi stated that he would have to go back and look at the estimate because the path would be 10 ft. wide so he would need to see if the \$75,000 would cover it. There was discussion of whether the bike path would have to be 10 ft. wide and Mr. Guzzi will check with the County. Mr. Keller asked for the cost of the new road and the bike path separately so the funding for these two projects comes from the correct line item. Mr. McDaniel asked about the trees and Mr. Guzzi responded that he was taking out only the trees needed for the reconfiguration project and leaving the remaining trees for Habitat to determine what they want to remove. Mr. Marinello asked if all the buildings were being demolished and Mr. Guzzi responded yes because the lots have to be cleared for Habitat pursuant to the contract. Mr. Guzzi stated that the septics will be demolished as well but the utility poles would be left. Mr. Guzzi stated that the Township will have to decide later whether they want to just keep an easement. Mr. Guzzi will advertise next week and receive bids in June for award in July. Mr. McDaniel asked if there is a way to put parameters for job completion and Mr. Guzzi responded that he could tighten up the time frame.

Mr. Sobotka stated that when they did the projects on Applegate Rd and Mt. Pleasant Rd. they used fill dirt for the side of the road and the fill dirt is all washed out. Mr. Guzzi responded that they are responsible to stray and tag it and that was some of the problems they had when they came back out. Mr. Sobotka also said there is a discoloration in the road on Mt. Pleasant and then there is a bump. Mr. Guzzi stated that they had the same problem on Smithville and Jobstown-Juliustown Rd.

Mr. Marinello asked about Folwell Station Rd and the collapsing storm drain and Mr. Guzzi stated the pipes all looked good but there may be settling under the piping so they are keeping an eye on it to see where it goes. Mr. Marinello asked if the contractor would be responsible and Mr. Guzzi responded that we called the bond on that and it was settled. Mr. Guzzi added that it does not appear there is any leaking in the pipes and he added that we should be able to repair it down the side of the drain.

Mr. Sobotka made a motion seconded by Mr. Hlubik to accept the Engineer's report. All were in favor. Motion carried.

#### SOLICITOR REPORT

Mr. Morris stated that Southampton does not have the ability to produce affordable housing in their Township so they have given up and are going to give their affordable housing money back so Kevin Walsh from Fair Share Housing intervened and said Southampton should give the money to Springfield Township to help Habitat produce the affordable housing on this project. Mr. Morris stated that the State has said no they want the money back and there will be a fight between the State and Fair Share Housing.

Mr. Sobotka made a motion seconded by Mr Hlubik to approve the Solicitor's report. All were in favor. Motion carried.

# MANAGER'S REPORT

Mr. Keller stated that we had a final meeting with the adjuster's from the insurance company and they wanted us to sure up the trusses and they are supposed to have a report by next week for us.

Mr. Keller stated that he has not received a response yet from the County regarding the parking.

Mr. Marinello stated that someone dumped about 60 tires on his property. Mr. Marinello stated that he had called the Township to have someone come out to pick up the tires and Mr. Keller stated that if the tires were dropped on his property it is the property owner's responsibility. Mr. Marinello asked if we can put some money aside to assist residents for this dumping. Mr. Marinello called the County and it was burdensome so he called someone else and it cost him \$2.00 a tire. Mr. Marinello would like to see a fund to provide this service to residents. Mr. Keller asked if the Township has the right to go on a property and do clean up. Mr. Morris stated that maybe we could look at the dumping ordinance to see if we could add something so that part of the fine would go into a fund for that purpose. Mr. Sobotka stated that it opens it up to people calling to get rid of any item they cannot dispose of. Mr. McDaniel asked if we can offer a contractor for a modest fee and Mr. Morris stated that as long as you are giving them more than one name.

Mr. Keller stated that we have the same problem with TVs now because the County can no longer recycle them because there is a bill in the legislature that is being held. Mr. Keller

stated that if you have a resident with a problem have them call him and we will see what we can do.

Mr. Marinello asked if the maximum fine is still \$1000 and Mr. Morris responded it is now \$2000. Mr. Morris will take a look at the litter Ordinance. Mr. Morris stated that you have not had a violation under this Ordinance in about two years.

Mr. McDaniel asked for an update on the two ambulances and the fire truck and Mr. Keller responded that we will be advertising the auction next week.

Mr. Marinello asked about the tree on Arneys Mt. Rd and Mr. Keller stated he could not find the tree and didn't see any dead trees. Chief Trout knew what tree he was talking about and it is in the County right of way. Mr. Keller will forward that to the County.

Mr. McDaniel stated that there is a drainage issue on Saylors Pond Rd and Mr. Keller will notify the County of that as well.

Mr. Marinello stated there is a tree on the side of the annex leaning across the road that needs to get looked at as well.

Motion made by Mr. Sobotka and seconded by Mr. Hlubik to accept the Manager's report. All were in favor. Motion carried.

#### **TOWNSHIP OFFICIAL'S BUSINESS**

Motion made by Mr. Sobotka and seconded by Mr. Hlubik to approve the game license for Judith Wotesek. All were in favor. Motion carried.

Mr. Sobotka attended the Northern Burlington School District Board meeting Monday night where the referendum was discussed. He stated that the first part was for classrooms and a lunchroom which would cost about 41 million, part 2 would be for an auditorium and cost about 10 million and the 3<sup>rd</sup> part would be for new gymnasium and cost about 7 million for a total of 58 million. Mr. Sobotka stated it was very confusing as to what the actual referendum will be and there may be up to 3 proposals. The State will pay 27 million towards part 1 only. Mr. Sobotka stated that they were vague about what the actual work being done with the 14 million the tax payers will be paying for part one. Mr. Hlubik asked what the cost to the tax payer will be and Mr. Sobotka responded that they did not give that information. Mr. Marinello asked if we know how many of our students attend Northern Burlington. Mr. Sobotka stated that the less students we send the more we pay. Mr. McDaniel added that it will flip but right now Springfield is feeling the pain.

#### **PUBLIC COMMENT**

Hearing no comments, Mr. Marinello made a motion seconded by Mr. Sobotka So to close public comment. All were in favor. Motion carried.

Mr. Sobotka made a motion seconded by Mr. Hlubik to adjourn the meeting. The meeting was adjourned at 9:49 PM. All were in favor.
